Your Insect Allies: Meet the Beneficial Insects that Control Crop Pests and Promote Soil Health

Implementing Landscape Stewardship Plans Through Collaboration

One Watershed, One Plan is focusing more and more on private forestland protection and management. Landscape stewardship plans are supporting this effort. Districts are playing key roles in coordinating the local implementation of forestland protection and forest management activities. The MN DNR Forestry Private Forest Management (PFM) Program is committed to working closely with districts, consulting foresters, and local partners to increase the delivery of services to private landowners. Reviewing the 2020 Farm Economics to Make 2021 Decisions on the Farm

This session will review the farm economics for Minnesota farms in 2020 including COVID impacts and opportunities. Additionally, we will review financial data from Minnesota Water Quality Certified Farms and compare it with noncertified farms. Finally, we will share a sneak-peak at 2021 as you work with farmers about various program decisions and potential technologies to consider when working with farmers.

Utilizing PTMApp for Planning and Project Implementation

The Prioritize Target Measure Application (PTMApp) has evolved significantly in the last few years and this training will bring participants up to speed on the status of the PTMApp model and what the web application are. Recently, the PTMApp model has been updated to consider specific USDA-NRCS practice types and to be utilized in Arc GIS Pro. The web application has been updated with a number of new watershed datasets and the reporting functions through the Scenario Builder has been greatly improved. This training will also provide examples of how the data has been used in developing comprehensive watershed management plans in Minnesota. Participants will see examples of how this data is being used for on the ground implementation with BWSR funds which will also be demonstrated. Lastly, we will survey participants on ideas on how they would like to use the data and what additions to PTMApp would be helpful to support the work they are doing.
